Establishment of GUC - Phase 1: 2000-2007 (1)

- 90es: Originating Ideas (Mansour, Wolff)
- > 2000-2003: Planning of GUC
 - Construction of Campus
 - Assignment of "Founding Deans" and GUC Boards
 - Design of Curricula
 - Recruitment of Scientific and Administrative Staff
 - Approval by Presidential Decree
 - Two Partner-Universities: Ulm and Stuttgart (Cooperation Agreement)









Establishment of GUC – Phase 1: 2000-2007 (2)

> 2000-2003: - Preparation for Accreditation

(cont.) - Support by German Government (DAAD)

- Support by State of Baden-Württemberg

- Support by Industrial Partnerships

Aim:

- Establishment of a Joint Master Degree between GUC and a Partner-University
- Excellence Program of Higher Quality than individual Master Programs
- Exchange of Students and Scientific Staff






Establishment of Joint Degree Programs: Joint Master Program Proposal (2)

Structure:

Joint M.Sc. Degree











Establishment of Joint Degree Programs: Joint Master Program Proposal (3)

Admission: - Based on B.Sc.-Degree with very good Results

- Application at Home University

- Evaluation and Proposal to the Partner University

- Final Acceptance by Partner University

- No further Qualifications (such as Entrance Exams)

Agreement:

 Joint Agreement as an Umbrella Approved by both Partner Universities

 Detailed Study Plans and Options (Appendix, Part of the Joint Agreement)









Establishment of Joint Degree Programs: Joint Master Program Proposal (4)

- **Study Plans**: Choice of a Major (which is offered at both Partner Universities)
 - Integration of an Extra Program to foster "Excellence" (Elite Program)
 - e.g.: > Research Internship in an Industrial R&D Dept. or Research Institution
 - > Course Program on Business Management and Administration
 - > Special Language / Cultural Programs





Establishment of Joint Degree Programs: Joint Master Program Proposal (5)

Funding: - Application with DAAD

- Establishment of an ERASMUS-MUNDUS Program

(EU)

- Private Company Sponsorships

Begin: - Winter Term 2007-2008





Exchange Progr. GUC - Partner Universities Germany (1)

Type of Exchange

(1)

1 or 2 Semesters Abroad

Definition

- Participation in Courses, Exams
- Performance of a Study Project
 (3 months equiv. B-Thesis)
 (6 months equiv. M-Thesis)
- Evaluation at Partner University
- Issuing of Complete Transcripts (but no Degree)









Exchange Progr. GUC - Partner Universities Germany (2)

Type of Exchange

(1) cont.

1 or 2 Semesters Abroad

Definition

- Acknowledgement by Home Univ.
 within the Home Study Program
 (analog. To European Erasmus
 Exchange Programs)
- Possibility to Extension to an Industrial Internship

Research Sabbatical

Definition

- Professors, Lecturers, TAs
- Research or Experience Stay at an Institute of the Partner University (short: up to 3 months, middle: 1 sem. long: 1 year)
- Possible Participation in Teaching/ Research Work Programs
- Funding by Home University
